- 1) We inform all teams and drivers that it is mandatory to have fire extinguishers under tents and on campers/motorhomes.
- 2) It is forbidden to drill the paddock areas on concrete or asphalt ground with pegs, otherwise the cost of restoration will be charged. Equip yourself with appropriate weights to secure tents or gazebos or suitable stops for fixing.

3) No one is authorized to position themselves in the paddock in a stable manner without prior agreement with the management, ask at the secretariat if there is no active service at the entrance gate.

The assignment of the place in the paddock is done by our collaborators at the entrance and we will do everything to accommodate you, but you will have to wait your turn even if you have already sent an email requesting paddock space.

All cars (including those of parents) must be left in the external area including unnecessary vans, mini vans and minibuses. AREAS ALWAYS UNATTENDED. 1 van per team will be authorized if there is space.

Loading and unloading of any kind must only take place at the entrance to the facility without entering the paddock.

- 4) Campers and motorhomes can arrive until 7.00 pm, paying the entire parking fee upon arrival to the person in charge as per the service list provided. Campers and motorhomes will be in the camper area until seats are available. Reservation is welcome. The showers are near the park toilet area, also open at night, you need tokens to collect at the bar.
- 5) From 10.00 pm, movement in the paddocks will no longer be permitted because silence will reign until 7.00 am.
- 6) Parents, those with legal authority, and team managers are invited to supervise minors at all times.
- 7) For participation in the various Events and the use of the assigned areas, the team/client self-certifies that the setup of the structures, the furnishings, the materials and products on display, as well as the installation and use of the areas comply with the directives European and Italian regulations in force regarding safety, prevention and protection and/or construction and materials.

The paddock, internal and external areas and camper and car parks are always unattended: everyone is responsible for their own paddock space, the structures, their own vehicles/vehicles and all material, before, during and after the event, exempting the kart track from any responsibility in case of shortages and/or omissions.

- 8) We recommend turning off the power every evening under the tents.
- 9) We recommend keeping the used paddock space tidy and clean using the bags that will be given to you at the entrance for undifferentiated waste. We invite you not to leave empty tanks and bulky materials in the paddock.
 Only put the rubbish bags outside your tent at the end of the day to allow for collection before the start of the event.
- 10) It is mandatory to place a ground sheet on each garage space in order to avoid soil pollution and damage to the same, under penalty of being charged for the cost of restoration.
- 11) As there is no current supply point for car charging, the same is FORBIDDEN.
- 12) At the end of the activity on the track, it will be closed with a ban on access even on foot.
- 13) We recommend not playing football on the trackside or on the access roads: we ask parents and team managers to ALWAYS supervise the drivers, especially minors.
